Keynote Speaker: *Derk Haank, CEO Elsevier Science*

History of the West Indisch Huis: The house owes her name to the period between 1623 and 1747 when the “Gentlemen Nineteen” ruled the scepter over the West Indisch Company. The privateering of Spanish ships at that time was the source of tremendous income and wealth. The largest conquest was the treasure fleet brought in by Piet Heijn. This fortune was hidden in the basement of the West Indisch House.

After the 80 years war with Spain ended in 1648 so did the privateering. The West Indisch Company soon found itself in financial difficulties and moved location to elsewhere in Amsterdam. In its 400 year history, the West Indisch House has been used as a gentlemen’s club as well as a home for orphans and the elderly. Since 1976, it has been owned and managed by the Foundation West Indisch House which restored the house to its original state after a fire raged there in 1975.
